So, thank you for living the Vincentian life and working with the poorest among us.



CONFERENCE STANDARDS OF EXCELLENCE

In the latest Frederic's E-Gazette the National president of SVdP, Ralph Middlecamp, wrote an article on Council and Conferences standards of excellence: https://ssvpusa.org/vincentians/11-3-2022-servant-leaders/

Here is an important thought from his article:

Most of us bristle a bit at the suggestion of compliance, but St. Vincent suggests that we should see following our structure and the guidance contained in our Rule as liberating. It may be why those who came before us used the title of "excellence" as the goal of this process. It is a blessing that the structure of the Society has been laid out for us, and our time and talent don't need to be spent in changing that.

The article has a link to a questionnaire, https://members.ssvpusa.org/information-for-members/standards-of-excellence/, that your conference needs to fill out at a meeting and then submit to the District Council. There are only about 35 questions. They are yes and no, but there is also a comment section to support the answer and to put in a plan to achieve compliance.

March is being discussed as a deadline for its completion. July is being viewed as a follow update to review what changes have been made. This may become an annual event and be submitted along with the annual report.

Please use it as a guide to make your conference the best conference that it can be and for giving the District Council information on how to help your conference be the best that it can be.



Home Visits in the SVDP

Ozanam wrote often about home visits:

He stated that the home visit to the poor was "our principal work." He reported regularly on the number of visits that various conferences had made. He saw the visitor and the visited as intimately united.

In 1836, he wrote, "We rejoice that the number of families that we are going to visit is growing, because it seems to us that they form, with the members who visit them, two parts of the same society. Those who are helped provoke and revive the charity of those who help them: In this way, they assist each other, they live in the same spirit, and all find shelter under the mantle of St. Vincent de Paul."



Home Visits in the Scriptures

Mark 1:29-31: Jesus visits Peter's mother-in-law and heals her.

Mathew 2:1-12: Wise men visit Jesus at this birth and bring him gifts. The account repeats three times that they come "to do him homage."

Mathew 25:36: Jesus declares that visits to the sick and those in prison will be one of the standards by which we are judged.

Mathew 26:6: Jesus visits the home of Simon the Leper, where a woman anoints him in preparation for his death and burial. He states that wherever the gospel is proclaimed, what this woman has done during his visit will be remembered.

Luke 1:39-45: Mary visits Elizabeth to assist her. They stay together for three months.

Luke 10:38-42: Jesus visits the home of Martha and Mary, where he teaches them about the "one thing necessary."

John 11:1-45: Jesus visits Martha, Mary and Lazarus and raises Lazarus from the dead.

The program allows them to have the dignified services that they would be otherwise unable to pay for.

Rents, Mortgage & Governance W-9s & 1099 By Pamela Hudson Johnson, National Director of Governance & Membership Services SVdPUSA

Landlords are required to provide W9 copies. Every SVdP rent paid should be made only after obtaining a copy of the landlord's W9. We should not assume that if the payment is less than \$600 a W9 is not required. We have found that there are many



Conferences that pay rent to the same landlords. \$600 accumulates quite fast.

Below is the information that published in the National e-gazette 9/16/21 edition. We strongly suggest following these guidelines. I have copied your District and Diocesan Council presidents for their guidance and feedback as they determine best. I have copied Steve Krank for local guidance as deemed necessary.

1099 Requirements for Services and for Rent Paid Directly to Landlords

After extensive research and consulting with both the National Council auditor and attorney, the National Council believes that once the total payments made by a Council or Conference for services or for rent payments to a landlord equal or exceed \$600 in a calendar year, a Form 1099 must be mailed to the recipient and filed with the IRS.

There are only a few *exceptions* to this requirement:

- · Payments made to corporations
- · Payments made to real estate agents or property managers acting on behalf of a landlord
- · Payments made to tax-exempt organizations (including governments)
- · Payments made via a third-party payment network (credit card, debit card or PayPal type service, but this does not include online bill payments)

All other payments for services or for rent payments to a landlord totaling \$600 or more in a calendar year will trigger the Form 1099 filing requirement.

Keep in mind that Forms 1099 are filed together for entities sharing an EIN, and if Conferences share an EIN with their Council, the Council will be required to combine all payments made to a service provider or landlord during a calendar year. It is recommended that records be kept of all payments to service providers and landlords, and Forms W-9 be requested and retained before making any service or rent payment, even if the payment is below the \$600 limit.

This is only a very summary of the rules. Councils and Conferences should review the complete IRS Form 1099 instructions and consult with their tax professionals for additional guidance. 2022-23 District Council & Family Resource Center Conference Visits

As a follow-up to the article in the November 2022 Vetera Monimenta, we hosted our first Conference Visit to the District Office and Family Resource Center (FRC) in mid-November. The St. Isidore SVDP Conference was the first to visit and tour. Jose Yanes, Conference President for St. Isidore, invited Fr. Mathew for the trip and Tour to introduce the scope and scale of resources available for our neighbors in need.

We have a place to eat & gather if it will help to draw each Conference to the FRC to understand more about the resources available to them in serving our neighbors. We recommend planning about 30 minutes for the tour and presentation, plus time for questions.

"By offering Conferences the chance to have a meal, or host their Conference Meetings at the DC, we can educate our members about the resources available and how they, as Vincentians, can access them to better serve our neighbors in need".

If each guest leaves with an understanding of the resources available and how they can access



what we do for those they serve, it would be a success and time well spent.

This Agenda is an idea of what we are presenting:

- Rota Care Pittsburg Free Medical Clinic at St. Vincent de Paul. 19,000 patient visits since opened >550 this year!
- Oasis Winter Nights Day Shelter Families with their kids and Safe Parking Program participants
- Workforce Development Program Providing Reentry, Mentorship, and paid Training to folks returning to the workforce through our Thrift Stores & Recycling programs.
- Dentist on Wheels Free Dental Clinic at St. Vincent de Paul- Our Three-Chair Dental Clinic averages 25 patients

per month (services include crowns, root canals, dentures, etc.)

- Free Dining Room Provides 150 200 hot meals daily in partnership with Loaves and Fishes of Contra Costa.
- Emergency Food Pantry, hygiene kits, and snacks for the homeless
- Thrift Stores & Warehouse provides free clothing to the homeless and low-cost furniture and acts as the primary worksite for our Workforce Development Program.
- HOPE Housing, Utility Assistance, Car Repair (provided \$1,015,290. +/- FY 2021-22) through the branches in 28 local Communities in Contra Costa County)
- Showers & Clothing for the Homeless in collaboration with The Bay Church
- Auto Donation Program Providing access to safe working vehicles where not having access is creating a barrier to sustainability.
